

# Register an out-of-state custody order in Washington

If you have a custody order or parenting plan from another state, and you, the other parent, or the children live in Washington State, learn how you might have to register the order here to make sure the order is followed in Washington.

## 1. Fast facts

---

### Why should I register my out-of-state custody order in Washington?

You must register it to be able to enforce it in Washington. **Enforcing** a court order means making sure that the person required to do something (or stop doing something in a court order does in fact do (or stop doing) it.

**Example:** Tai and Jo were divorced in Oregon. The Oregon court gave Tai custody of their young child and Tai visitation on Saturday mornings. Tai and the child have moved to Washington. Jo routinely returns the child a few hours late, which violates the custody order and is disruptive for the child.

Tai has talked to Jo and written emails about returning the child when the order says to, but Jo refuses. If Tai wants to take further legal action, like filing for contempt, to get Jo to follow the Oregon custody

and visitation order, Tai must first register the Oregon order in Washington.

## What will it cost me to register an out-of-state custody order in Washington?

There might be a filing fee to register this order. If you think you can't afford it, you can [file a Motion for Filing Fee Waiver](#).

You must file 2 copies of your out-of-state custody order. One must be certified. You can get a certified copy from the clerk of the court where the order came from. You'll probably have to pay for this.

## Do I have to let the other party know I'm doing this?

Under state law, the court (Court Administration) must notify the other party. We explain how to give Court Administration your papers and have them notify the other party.

## (I got my Order registered. Do I need to do anything else to enforce it?

If the other party still doesn't follow the Order, you may need to [file a motion for contempt](#).

## 2. Register your out-of-state order

---

1. [Fill out the forms](#).
2. Make 3 extra copies of each document:

- One copy for you
  - One for the other party's lawyer (or the other party if they don't have a lawyer)
  - One for copy for Court Administration
3. File your originals with the clerk and deliver copies.
4. Ask the clerk where to find Court Administration. This is a different office than the clerk's office.

Take 2 sets of copies of your forms to Court Administration. Leave one set with that office. Have them date-stamp the other set. This will be your copy.

Follow the general rules to format and fill out court documents.

For the caption of each form you fill out, look at the top of the first page of the custody order you want to register. Copy its caption, except for the county and

state. You'll substitute the county where you're registering this custody order and put Washington.

### **Tips for filling out Request to Register Out-of-State Order, FL UCCJEA 801**

If you don't want the other party to know where you live, put a P.O. box number if you have one, or put the address of a friend or relative you trust to tell you immediately if you receive any legal papers.

### **Tips for filling out Notice of Registration of Out-of-State Custody Order, FL UCCJEA 802**

Just fill out the caption. Don't make any other changes to this form.

### **Tips for filling out Court's Proof of Mailing, FL UCCJEA 803**

Put the last known mailing address you have for the other party.

Court Administration will fill out the rest after you've filed your completed forms with the Clerk's Office. Under state law, the Court, not you, must send the other party this notice. You can call Court Administration ([https://www.courts.wa.gov/court\\_dir/?fa=court\\_dir.county](https://www.courts.wa.gov/court_dir/?fa=court_dir.county)) to make sure they've sent the other party this form.

### **Tips for filling out Notice: Out-of-State Custody Order Confirmed without Hearing, FL UCCJEA 806**

Court Administration will file this form **only** if the other party doesn't object and schedule a hearing by the deadline. After filing this form, you're done. You can enforce your order in Washington State.

If the other party **does** object, skip this form. You must fill out and file the FL UCCJEA 805.

### **Tips for filling out Order about Registering Out-of-State Custody Order, FL UCCJEA 805**

If the other parent has filed a Motion to Dismiss and scheduled a hearing by the deadline, you should fill this out as a proposed order to ask the judge to sign at the close of the hearing.

## 4. Hearing

---

If the other party has scheduled a hearing, you must get ready for it and then go to it, even if you don't think there's any reason to stop you from registering your court order in Washington.

**Need an interpreter?** You have the right to interpreter services in court at no cost to you. Each court should have a contact person for interpreter requests. As soon as you find out about a court date, contact the court to ask for an interpreter.

**Need accommodations?** Ask for accommodation for a disability that limits your ability to take part in a court hearing or trial. Each court should have a contact person for ADA requests. You can use the state's Request for Accommodation form (<https://www.courts.wa.gov/forms/?fa=forms.contribute&formID=71>). As soon as you find out about a court date, contact the court to make this request.

## Request to Register Out-of-State Custody Order

### 1. Registration

I ask the Court to register the current out-of-state custody order/s. I will file any request to enforce the out-of-state order/s using this case number.

### 2. Confirmation that order is valid

The out-of-state custody order/s I am asking the court to register is/are currently in effect and have not been changed (modified).

### 3. Person requesting registration

I am a parent or person acting as a parent who has custody or visitation with the children under the order being registered.

### 4. Other parties

The other parties are every other parent or person acting as a parent who has custody or visitation with the children under the order/s being registered.

### 5. Confidential Information

I am filing the *Confidential Information* form (FL All Family 001) separately to provide mailing addresses and other information about the parties.

### 6. Attachments

I am attaching the following documents to this *Request*:

- Two copies of the out-of-state custody order/s currently in effect (one copy must be certified); and
- A *Notice of Registration of Out-of-State Custody Order* (form FL UCCJEA 802).

## 7. Notice

I ask the court to notify the other parties of this registration as required by RCW 26.27.441.

**Clerk's action:** Deliver **copies** of this *Request* and all attachments to the Court Administrator or other appropriate court personnel to send to all other parties.

## Notice of Registration of Out-of-State Custody Order

The attached out-of-state custody order has been registered in Washington State. Now that it has been registered, it can be enforced the same as a Washington custody order.

If you believe this custody order is **not** valid, you can ask the court for a hearing. To do that, fill out and file a *Motion to Dismiss Registration of Out-of-State Custody Order and Notice of Hearing* (FL UCCJEA 804).

**Deadline!** You have **20 days** after you are served this *Notice* to file your *Motion*.

If you miss the deadline to file a *Motion*:

- The registration of the custody order will be confirmed, and
- You will not be able to challenge its validity in the future.
