This procedure is a last resort to recover your children if the other parent or person claiming the right to legal custody has abducted them. (Forms and instructions)

1. Fast facts

What is a writ?

A Writ of Habeas Corpus is a court order demanding some action from a sheriff or other person. In family law cases, the court order demands that a parent turn children over to the court.

A writ orders law enforcement to take custody of the children and **bring them to court**. The writ **won't** tell law enforcement to give the children to you. When law enforcement brings the children to court, a judge decides what happens to the children next.

A judge can order a warrant with a writ that gives law enforcement the power to:

- Break and enter to find your children
- Arrest anyone who stands in the way of getting the children back

When can I get a writ?



Judges rarely use this powerful and extraordinary tool. It could be traumatic for the children to be taken from the abducting parent by law enforcement. CPS could get involved. The children could have to spend a night or two in foster care until they can get to court and see a judge.

Usually there are other things you can do to get your children safely back when the other parent has taken them. You should ask for a writ in your custody situation **only as a last resort** when other things you've tried have failed, or if the other parent might disappear with the children if you did anything else. Don't use the writ just to try to get out of a longer court procedure, such as <u>contempt</u> or a petition to change parenting plan.

How do I get a writ?

It depends on the county. Generally, you file a Petition in the county Superior Court where the child is right now (or where you believe the child is) with a certified copy of the order giving you custody. The judge will decide whether to give you a writ and whether to give law enforcement the power to use forcible entry or arrest to get the children back.

Talk to law enforcement before starting this procedure. It may save you time and money. Law enforcement will understand the legal elements your paperwork must meet. They may advise you not to use this process. Or they may do a criminal custodial interference investigation and arrest the abducting parent. Then you wouldn't need a Writ.

Law enforcement usually charges to serve a writ. Even if a <u>judge</u> waives (excuses) your court filing fees, you'll probably still have to pay the sheriff's fee for service.

2. Step-by-step

These 7 counties have their own forms for getting a Writ: Chelan, Clark, Cowlitz, King, Klickitat, Pend Oreille, Snohomish. If you're filing in one of these counties, ask their clerk

(https://www.courts.wa.gov/court_dir/?fa=court_dir.county) or family law facilitator



(https://www.courts.wa.gov/court_dir/?fa=court_dir.facils) for their forms and what their procedure is. If your county doesn't have its own forms, use ours.

This is a very hard procedure to do on your own. Try to talk to a lawyer

- 1. **Talk to law enforcement** to make sure this procedure is right for you. You'll need to coordinate with them to serve the Writ if you get one. It's best to start working with them as soon as possible.
- 2. **Get at least 3 certified copies of your Parenting Plan or custody order.** If you don't already have a court order giving you custody of the children, you'll probably have to ask a court for one before you petition for a Writ.

If the person who took your children **isn't** the other parent and **doesn't** have legal guardianship or custody, you may not need a court order. You can try to use a certified copy of the child's birth certificate or parentage order to show that you are a legal parent and the other person isn't.

- 3. <u>Fill out the forms completely</u>. There's a fee to file for a Writ of Habeas Corpus. It could cost a few hundred dollars. If you can't afford it, also fill out the forms to ask the judge to cancel (waive) the filing fee.
- 4. **Make multiple extra copies of the Petition for a Writ.** You'll need at least one copy for you, one for law enforcement, one for the other party, or their lawyer if they have one, and one copy to give the judge (called <u>working</u> copies) for when a hearing gets scheduled.

Make at least 2 copies of the Missing Child Information and the Law Enforcement and Confidential Information forms. These forms **don't** get served on the other party.



Wait until the judge signs your proposed Order to Issue Writ of Habeas Corpus and Warrant in Aid of Writ to make copies of that form. You'll need certified copies with the judge's signature and the clerk's seal.

Make at least 2 copies of the proposed Order Directing Return of Children. Bring these to the hearing.

5. Go to the Superior Court Clerk's office.

Tell the clerk you're filing for a Writ of Habeas Corpus. Give the clerk the originals of your Petition, the Law Enforcement and Confidential Information form, and your proposed Order to Issue Writ of Habeas Corpus and Warrant in Aid of Writ. If you can't afford to pay the filing fee, also give the clerk your fee waiver papers. Otherwise, pay the filing fee.

Don't give the clerk the **Missing Child Information** unless the clerk agrees it can be filed under seal. Otherwise, this will be a public record and the other party may see it.

Follow the clerk's instructions to have a judge review your papers. The judge will sign the Writ if the judge decides you need it. The judge will also decide whether to issue a Warrant in Aid of Writ. Without a Warrant in Aid, law enforcement has no legal right to make forcible entry or arrest. **But they can still serve the Writ.**

If the judge won't sign your Writ, stop here. Talk to a lawyer.

If you asked for a filing fee waiver, but the Judge won't sign that Order, you must pay the filing fee.

Ask the clerk to stamp your copies to show the date you filed the originals. Take the stamped copies back from the clerk. The clerk keeps the originals.

6. Get certified copies of the Writ from the clerk and deliver them to law enforcement. You may have to pay for certified copies. Ask in advance how many copies they need. Also give law enforcement a copy of your Petition



and the Missing Child Information.

7. Coordinate with law enforcement to serve the Writ and recover the children.

Law enforcement won't give the children directly to you. The Writ orders law enforcement to bring the children to court where a judge decides what happens next.

Once law enforcement picks up the children, they'll work with the judge's clerk or assistant to schedule a <u>return hearing</u>. They try to have the hearing the same day, if possible, so the children don't have to spend a night in foster care. The clerk will probably call to tell you when the hearing will be. Follow the clerk's instructions.

- 8. **Go to the return hearing.** Read chapter 3 for how to get ready for and what to expect at the hearing.
- 9. **Get copies of any orders the judge signs.** Ask the clerk how to get the copies you need.

3. Hearing

After the judge signs your Writ, be ready to go to a return hearing at any time. You may get very little advance notice. Even so, try to get to the hearing early. Give yourself time to get through security and find the right courtroom.

Organize your paperwork. Plan to bring your set of court papers and your copies of any papers the other parties gave you in response. Bring extra copies of the proposed Order Directing Return of Children that you want the judge to sign.

Bring your paperwork, a pad of paper, and a dark pen to take notes.



When you get to the courtroom, tell the person in charge in the courtroom (the clerk or bailiff) your name and your case name and number. Take a seat. When the judge walks in, stand.

When your case is called

You usually won't be able to testify, have witnesses testify, or otherwise give evidence at the hearing. You'll just get to tell the judge briefly what you want and why. This means you want to prepare beforehand by making notes about the main points you want to say to the judge.

If the other party shows up at the hearing, each of you will tell your side of the case. Stand while speaking. Tell the judge briefly what you want and why. Try to keep your argument short. Only outline your main points. You may have as little as 5 minutes to speak. Don't repeat everything in your papers. Ask permission to hand your proposed order up to the judge.

If the judge asks you a question, try to answer it directly. **Don't interrupt the judge.**

After the judge has heard both sides, and possibly from law enforcement or CPS, the judge will probably sign an <u>Order Directing Return of Children</u>, directing the release of the children to one of you. **Listen carefully.** If you don't understand something after the judge finishes speaking, ask the judge to clarify.

If the other party doesn't show up at the hearing, the judge will probably go ahead with the hearing anyway so the children can be released.

Before you leave, make sure you know if you must file any more paperwork or attend any future hearings. Ask the judge or clerk if you're not sure. Ask the clerk how to get copies of any orders the judge signs.

Follow the general rules to format and fill out court documents.

Fill out the Petition, Missing Child Information, and Law Enforcement and Confidential Information (LECIF) forms as completely as possible.

Tips for filing out the Order to Issue Writ of Habeas Corpus

This is a proposed order. Fill it out the way you want the judge to sign it.

Fill out the top area (case caption) and sections 1 and 2. Fill out names and addresses in sections 5 and 6 as you can and check the boxes that you want the judge to order. If you're not sure of something, leave it blank for the judge to complete. Sign and print your name at the end where it says "Petitioner."

Tips for filing out the Order Directing Return of Children

This is the proposed order you'll ask the judge to sign at the return hearing, after law enforcement has recovered the children. Fill it out the way you want the judge to sign it.

Fill out the top area (case caption) and sections 1 and 2. Put your name in section 3.

If you already have a No-Contact Order, Protection Order, or Restraining Order protecting you and the children, you probably don't need the Restraining Order in this form.

Ask for reimbursement of fees and costs if needed. Keep your receipts.

You can leave the "Other orders, if any" section blank, or put anything else you want the judge to order here. For example, you may want an order requiring the other parent to return the children's property or passports.
